

## **PROVINCE-WISE PRESENCE**

AKUH has a pan-Pakistan presence enabling us to provide quality healthcare to needy patients across the country.



## **IN-PATIENT SERVICES**

More than 73% of the PBS for AKUH raised in 2021 was used to support 1,379 in-patient visits to the Stadium Road facility and four secondary hospitals in Karachi.

The highest number of in-patient visits supported by PBS were for babies and children. In 2021, 583 paediatric visits were supported through a sum of PKR 105.49 – 36.3% of the total in-patient zakat disbursement. Your generosity has had a profound impact on the lives of future generations. Further details of inpatient support are listed on the next page.

## **MENDING A HOLE IN A HEART**

"My name is Muhammad liaz Khan. I am a Muazzin and teach the Quran to children. Three years ago, Allah (swt) sent us a little angel, Muhammad Moiz, who was the joy of our hearts. I would dream of making him a big scholar of Islam. But as my child grew up. I found him withering in front of my eyes. At the age of 6 months, he was continuously sick.

Whatever meagre resources I had, I took him to many doctors who conducted all kinds of tests. It was eventually diagnosed that my child had a hole in his heart which required expensive surgery. I prostrated to Allah (swt) and implored him. Friends guided us to the Aga Khan University Hospital (AKUH) where we were assured medical assistance and help through PBS and Patient Welfare. The successful surgery was conducted by an expert team of health professionals with love and respect and the generosity of the donors who opened their hearts for people like us, brought tears of gratitude in our eyes and duas for them as long as we live.

# SUPPORTING ZAKAT MUSTAHIQ PATIENTS TO ACCESS QUALITY LAB TESTING

Recognising that early detection, diagnosis and treatment of disease in patients can save lives and that medical laboratory testing plays a critical role in early detection, PBS has started an initiative to help zakat mustahiq patients avail significantly reduced lab test charges.

Currently, thanks to support from AKUH's patient welfare programme donations, AKUH is able to able to subsidise the cost of lab tests for lowincome households by up to 40%. To enable even greater access for zakat mustahig patients, PBS is now seeking to provide an additional 40% reduction for lab test charges. The programme has been launched at 8 phlebotomy centres which are either near public sector hospitals or in low-income neighbourhoods. In total, these centres test on average 120,000 patients a year, approximately 50% of whom are from poor households. Through zakat contributions mustahig patients will have access to reliable diagnostic testing, enabling early diagnosis and treatment for disease.

In 2021, 12,794 zakat mustahiq patients were supported to get discounted lab tests at AKUH's phlebotomy labs.



## LAUNCH OF HEPATITIS C PROGRAMME

Hepatitis is an inflammation of the liver and of the five main hepatitis infections, Hepatitis B and C lead to chronic disease in millions of people and are the most common cause of liver cirrhosis and cancer. Sadly, Pakistan has the second highest global burden of Hepatitis C (HCV) infections, with an estimated 5% of the population infected (i.e., eight million people). However, antiviral medicines can cure more than 95% of people with HCV infections if there is access to diagnosis and treatment.

To help eliminate Hepatitis C in Pakistan, AKUH's Outreach Health Network in 2021 launched a programme to provide screening, diagnosis, treatment and post-treatment to infected patients. Through partnerships with Getz Pharma Pakistan, Roche Diagnostics and donations from its Patient Welfare Programme the cost of treatment for needy patients has been reduced by 75%. In order to help zakat mustehia patients receive treatment for free, PBS launched a campaign to raise funds for this important initiative, so that every year 6,000 needy patients across Pakistan can be treated at AKUH's Outreach Medical Centres.

Launched in July 2021, the Hep C Initiative has conducted more than 60 marketing camps in 9 cities across Pakistan and screened over 13,000 patients through rapid testing for HCV antibodies. Of these, 1,671 patients were enrolled in the screening package, 1,383 in the diagnostics package and treatment of 390 has started.

## **EBRAHIM SIDAT** FOUNDING MEMBER, **PBS FOR AKUH**

We had a chance to talk with Ebrahim Sidat, one of the founding members of PBS for AKUH, who shares his journey and vision for the organisation.

#### When did you start supporting The Patients' Behbud Society for AKUH (PBS) and why?

I was one of the pioneers of PBS. My association started in 2001, when the then President Shamsh Kassim-Lakha approached and asked me whether a system could be set up within AKUH for collecting zakat in a Shariah-compliant way. This gave me an opportunity to articulate a system and I had the privilege and honour of drafting PBS's constitution. We started operations in 2002 and I have been a member of the Executive Committee since then.

#### What, in your opinion, have been the significant achievements of PBS over the past five years?

I think the one of the greatest achievements in PBS's history so far has been gaining Shariah certification. When we got the certification there was no such practice at other hospitals in Pakistan, we were truly the first movers. Why did we make efforts to get the certification? Because we have nothing to hide, we wanted to be as transparent as possible and to show our commitment to following Shariah principles and quidelines for the management of zakat, sadaqat and

other donations. We work very hard to maintain our Shariah certification. it is renewed every year following a detailed Shariah review and is a stamp attesting our financial propriety.

Other achievements over the past five years is the expansion of our membership to include people from different walks of life, this has enabled us to reach more people beyond Karachi and raise awareness of PBS's work and impact.

Another achievement I am particularly proud of is PBS' support for separating the conjoined twins, Muhammad Ayan and Muhammad Aman in December 2020. This extremely complex operation was a huge success and would not have been possible without your support to PBS. The operation has enabled these brothers to live a healthy and normal life.

#### Where would you like to see PBS in the next five years?

Over the next five years I am very hopeful In Sha Allah that there will be a larger fund base available so that we can help a lot more patients from across the country. Currently many needy patients from other provinces, despite knowing about the high-quality of care, are hesitant to come to the Aga Khan University Hospital in Karachi for fear they



won't be able to afford the treatment. We want this to change, we strongly believe that quality healthcare should be available for all.

#### Would you recommend PBS to donors as the best institution to give zakat to?

I would definitely recommend PBS to donors. Within AKUH, there are sound systems of control and transparency and the PBS Executive Committee takes the responsibility of ensuring this very seriously, especially as zakat is being discharged systems and transparency in policy as a means of faith, 100% of the funds given to PBS are going to treat mustahig patients and all patients are treated equally at AKUH, as the doctors and medical staff are unaware who is paying for their treatment and who isn't. Our vetting process is highly transparent and patients from throughout the country are evaluated for eligibility for financial assistance. In many cases it is seen that AKUH becomes the hospital of last resort

and patients come here when no other hospital is able to resolve their complex healthcare problem.

As a Chartered Accountant, financial and practice are of upmost importance to me and I can confidently say that AKUH PBS is structured in a way that safeguards against any financial impropriety. We are committed to giving donors 100% confidence in our systems and to maintaining our reputation as an organisation of integrity and that is why I can say with my hand on my heart that AKUH PBS is one of the best - if not the best - organisations to give your zakat to.

Like their complex surgery, Muhammad Ayan's medical care is being supported through zakat and the Patient Welfare Programme.



#### Opinion

- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

#### 1. GENERAL INFORMATION

1.1 The Patients' Behbud Society for AKUH (the Society) formerly named as "The Patients' Welfare Society" until 2002 was established by well-wishers of the Aga Khan University Hospital (the Hospital) under a constitution dated June 22, 1993 (the Constitution) for supporting needy patients seeking treatment at the Hospital, clinics and medical centers under its management and supervision through Zakat fund available with the Society. The Society is currently governed and managed under the amended Constitution of 2002. The Society is registered under the Voluntary Social Welfare Agencies (Registration and Control) Ordinance, 1961 (XLVI of 1961) since August 23, 1993. The principal office of the Society is situated at the Hospital. Stadium Road. P.O. Box 3500, Karachi 74800.

The following funds are being managed by the Society in order to pursue its aforementioned objectives:

#### (a) Zakat / Donations - Externally Restricted

The Zakat Fund of the Society has been established for providing financial assistance to needy patients seeking treatment at the Hospital through Zakat available with the Society. Major contributions to this include zakat collected, transfer by the Society from the surplus as well as donations received from various sources.

#### (b) General Fund - Unrestricted

General Funds are utilised for meeting marketing and administrative expenses of the Society. Donations contributed by the donors for marketing and general purposes / operations are recognised under the General Fund upon receipt.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

#### 2.1 Basis of preparation and statement of compliance

These financial statements have been prepared under the historical cost convention except as otherwise disclosed in the accounting policies below.

These financial statements have been prepared in accordance with the requirements of Revised Accounting and Financial Reporting Standards for Small Sized Entities (Revised AFRS for SSEs) and the Accounting Standard for Not for Profit Organisations (Accounting Standard for NPOs) issued by the Institute of Chartered Accountants of Pakistan (ICAP).

#### 2.2 Cash and Cash Equivalents

Cash and cash equivalents comprise of deposits with banks and short-term investments with banks having an original contractual maturity of less than three months.

#### 2.3 Revenue recognition

- Zakat / Donations are recognised on receipt basis.
- Profit on bank balances and short term investment is recognised on a time proportion basis on the
  principal amount outstanding using the applicable profit/mark up rate.
- Donations in kind are recognised at fair value.

#### 2.4 Disbursement

Disbursements are recognised as commitments when these are approved by the Executive Committee. Subsequent to approval, these amounts are paid to the Hospital on behalf of Mustahiqeen patients.

#### 2.5 Taxation

The Society does not account for taxation, as non-profit organisations are allowed a tax credit equal to one hundred percent (100%) of the tax payable including minimum tax and final tax payable, under section 100C of the Income Tax Ordinance, 2001.

#### 2.6 Financial assets and liabilities

Financial assets and financial liabilities are initially measured at cost, which is the fair value of the consideration given and received respectively. These financial assets and liabilities are subsequently measured at fair value, amortised cost or cost as the case may be. Financial assets and financial liabilities are recognised when the Society becomes a party to the contractual provision of the instrument. Financial assets are derecognised when the rights to the cash flows from the financial assets expire or where the Society transfers the financial assets and the transfer qualifies for derecognition. Financial liabilities are derecognised when the obligation specified in the contract is discharged or cancelled or expired.

#### 2.7 Off-setting of financial assets and financial liabilities

Financial assets and liabilities are offset and the net amount is reported in the statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle either on a net basis, or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the Society or the counterparty.

#### 3. SIGNIFICANT ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of financial statements require management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expenses. Actual results may differ from these estimates. Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances. Presently no significant estimates / judgements have been made for the preparation of these financial statements.
