As a registered, independent charitable society accredited by the Pakistan Centre of Philanthropy (PCP), PBS is committed to providing *mustahiq* patients with high-quality treatment at AKUH, its secondary hospitals and its outreach health network.

With 100% of Zakat and donations directly supporting patient care while all

administrative expenses are fully borne by AKUH, PBS upholds the highest standards of fairness and transparency.

Following Shariah-compliant assessment guidelines, PBS ensures that every contribution reaches those who need it most, offering them the opportunity to seek care with dignity and respect.

The generosity of our donors enables PBS to provide hope and life-saving medical treatment to deserving patients across Pakistan.

### **Establishment and Governance**



- The Society was established.
- Constitution and by-laws were developed with the assistance of legal and Shariah specialists.

### **Certifications and Accreditations**



- PBS received its first PCP certification for ensuring transparency and accountability in its operations. This certification is renewed every three years.
- PBS received its first Shariah Certification based on an extensive review of its processes and documents by two respected scholars, Mufti Ibrahim Essa and Mufti Ahmad Afnan. This certification is renewed on a yearly basis.

# Making Dignified Healthcare Accessible for Those Who Need it the Most

AKUH is Pakistan's premier healthcare institution, renowned for delivering high-quality care that meets international standards. With its unwavering commitment to excellence and a patient-centred approach, it stands as a beacon of hope, offering advanced medical expertise and resources to ensure the well-being of every patient.

Outside the clinics, many individuals from underprivileged backgrounds wait for their turn, who cannot afford the cost of treatment.

How do these patients access world-class medical care at AKUH?

The Patient Welfare Programme (PWP), makes high-quality, critical healthcare accessible to these patients enabling them to benefit from the full range of cutting-edge clinical, diagnostic, and laboratory services at AKUH and its outreach centres. Inspired by AKU's guiding principles of Impact, Quality, Relevance and Access, the Programme ensures that the neediest have access to reliable healthcare services with dignity and respect. The Programme upholds the hospital's mission of healing everyone with compassion, regardless of their financial circumstances.

In 2024, a survey by the Patient Welfare Department revealed that 100% of respondents strongly agreed that their dignity and privacy were upheld and that they received the same quality of treatment as patients who did not receive welfare support.

Funded by donations, Zakat and AKUH's own resources, the PWP has supported millions of deserving patients from across Pakistan. PBS plays a critical role in supporting the PWP through the collection and disbursement of Zakat and donations.

Since its inception in 1985, PWP has supported over 10 Million patient visits providing more than PKR 41,000 Million in welfare assistance.

In 2024 alone, the Programme supported 1.49 Million patient visits by disbursing over PKR 7,000 Million out of which PKR 1,228 Million was contributed by PBS.




#### THE IMPACT OF YOUR GENEROSITY TO PBS

## Beating Congenital Heart Disease: Kawish's Journey



Life in the remote village of Missan, in Tando Allahyar, Sindh, is full of challenges unknown to many residing in urban areas. For Asif and his wife, these struggles became unbearable when their two-month-old baby, Kawish, began showing signs of illness. The joy of parenthood was quickly overshadowed by fear and uncertainty as Kawish's breathing grew irregular.

The local hospital brought the devastating news that Kawish had three holes in his heart and his lungs were reversed. This rare and life-threatening condition left Asif and his wife grappling with despair. Their doctor told them that the treatment Kawish urgently needed was only available at AKUH in Karachi. Clinging to a glimmer of hope, the family embarked on a long journey to Karachi, praying for a miracle.

At AKUH, Dr Saleem Akhtar, a skilled paediatric cardiologist, diagnosed Kawish with Cyanosis, a condition where oxygen levels in the blood are dangerously low. "The condition of Kawish was very critical, and his diagnosis was complex. After thorough investigations, we found him suitable for surgery," explained Dr Waris, a renowned cardiothoracic surgeon at AKUH.

After a nine-hour surgery, when the surgeon finally emerged with the news that Kawish's operation was successful, tears of relief and gratitude flowed from his parents' eyes. Their journey from despair to hope had finally reached a joyous conclusion: Kawish was on the road to recovery.

None of the expenses for this life-saving surgery were borne by the family. All costs was covered by PBS.

Thanks to the expertise of AKUH's medical team and the generosity of PBS donors, Kawish now has the chance to grow up healthy and strong.

His story stands as a powerful reminder that compassion and expert care can save lives and bring hope where it is needed most.

### Phlebotomy Zakat Programme Expanding access to life-saving diagnostics

Your support is saving lives by enabling early detection and diagnosis of diseases.

In 2020, PBS launched a programme to further ease the financial burden on Zakat *mustahiq* patients by subsidising laboratory test costs through Zakat donations.

This initiative provided an additional 20% subsidy on top of the existing 40% support, ensuring greater access to


high-quality diagnostics for early intervention and better treatment outcomes.


Initially implemented in two labs in Karachi, the Programme has now expanded to 119 labs across Pakistan.


Thanks to the generosity of our donors, these labs are strategically located near public sector hospitals and low-income neighbourhoods to serve the most vulnerable communities.



### PBS's support since inception of the Phlebotomy Zakat Programme









# **Combatting Hepatitis C in Pakistan**

Hepatitis C (HCV) is a major public health challenge in Pakistan, where an estimated 8% of the adult population is infected—giving the country the highest HCV infection rate in the world. This blood-borne virus causes liver inflammation, leading to chronic disease, liver failure and cancer. Most infections occur in healthcare settings, often without patients' knowledge. Dubbed a silent killer, HCV can remain undiagnosed for years until complications arise. However, antiviral medicines can cure over 95% of cases if patients receive timely diagnosis and treatment.



### **Hepatitis C Elimination Programme**

To combat this crisis, AKUH launched a nationwide Hepatitis C Elimination Programme in July 2021 in collaboration with PBS and pharmaceutical partners, Roche Diagnostics and Getz Pharma. Leveraging AKUH's expertise in community health, diagnostics and patient care, the Programme offers comprehensive screening, diagnosis, treatment and post-treatment care.

Medical camps have been set up in more than 40 cities, including in Central Jail Karachi, ensuring vulnerable populations receive critical screenings. Partnerships with organisations such as UBL, Hamdard Foundation, Sukkur Beverages Ltd, United Resources, the Government of Sindh and NGOs like Pannah, Nai Zindagi and the Zubaida Machiara Trust have expanded the Programme's reach.

Through a collaboration with the Oil and Gas Development Company Limited, numerous camps have been conducted at factory sites for local communities.



# Fighting a Silent Enemy: Bahadur's Recovery from Hepatitis C



Bahadur Ali, a humble daily wage earner, spent much of his life battling poor health and financial hardship. Unknown to him, a silent enemy, Hepatitis C was ravaging his body from within. Frequent illnesses and life's complexities left him feeling hopeless but his fear of needles made him reluctant to undergo medical tests. During a medical camp, Bahadur's brother insisted he take a blood test.

Despite his fear of needles, he agreed and this decision changed his life. The test revealed that he had Hepatitis C.

Initially overwhelmed, he found solace and hope through the generous support of PBS donors that enabled his treatment.

Due to early detection, his illness was treatable and after completing months

of treatment, his health significantly improved.

Today Bahadur has fully recovered and is deeply grateful to the AKUH and the donors of PBS for providing him with a dignified healing experience and saving him from the deadly grip of Hepatitis C.

Bahadur Ali is one of 8,153 Hepatitis C patients who received support from The Patients' Behbud Society for AKUH since the inception of the Programme.

# Surviving the Unthinkable: Zareena's Story



Zareena was on her way to a wedding, riding on her cousin's bike with her nephew following closely behind. In a tragic turn of events, an accident occurred. While the initial crash was severe, the true devastation came moments later—her nephew's bike was struck from behind, sending him hurtling into Zareena with immense force. The impact caused a catastrophic brain injury. She was rushed to AKUH where expert neurosurgeons performed an intricate, life-saving procedure. Her injuries were extensive and the trauma had also severely affected her vision.

Recognising the urgency of her case, doctors not only carried out complex neurosurgery but also performed delicate eye surgery to prevent further deterioration of her sight.

For six months, Zareena lay in a coma, her life hanging in the balance. Her survival and recovery were made possible by the exceptional care at AKUH and by the generosity of donors supporting PBS. Due to the contributions, she received the critical treatment she needed, free of financial burden.

Today, Zareena is a testament to resilience, medical excellence and the power of compassionate giving. Due to generous donors like you, she now has a renewed hope for the future.

In 2024, The Patients' Behbud Society for AKUH, disbursed PKR 48.3 Million for Neurosurgery and PKR 55.8 Million for ENT surgery to support deserving patients like Zareena.

# Daniyal Hears Again: A Life Transformed by a Cochlear Implant



"My little Daniyal's world was wrapped in a deafening silence since birth. Other children in the house would respond to our calls and the noise from Karachi's busy streets, but my baby remained clueless. That's when I slowly realised something was wrong," shares Sumaira.

A resident of Karachi, Sumaira's joy knew no bounds when she gave birth to Daniyal, her second son. However, her happiness turned into heartbreak when she discovered that Daniyal could not hear.

"The thought of gathering the enormous amount of money needed for his treatment felt impossible, so we desperately tried every other option first," she recalls.

From relying on an amulet to trying a hearing aid, and traveling across Multan, Sargodha, and Lahore in search of a spiritual cure, Sumaira clung to every shred of hope. Yet, she eventually accepted that only medical treatment could give Daniyal the ability to hear.

Fate finally brought Sumaira's family to Dr Sohail Awan, a compassionate ENT surgeon at the AKUH.

After a successful cochlear implant surgery, he shared the news, "Mubarak ho, aapka beta ab sunay ga bhi aur bolay ga bhi."

Today, Sumaira's gratitude knows no bounds. She is grateful to Allah and AKUH for restoring Daniyal's hearing and giving him the chance to speak. She is especially thankful to PBS, whose generosity and support made this transformative treatment possible.

Daniyal's story is a powerful testament to the skilled care and the compassionate support of our donors that made such healing possible—bringing sound and hope to a once silent world.

In 2024, The Patients' Behbud Society for AKUH, disbursed PKR 28 Million to deserving patients for Cochlear Implant Surgery.

# Battling Leukaemia: Umais's Path to Recovery



In the narrow, bustling streets of Baldia Town, Muhammad Umais grew up under the care of his uncle, Mushtaq Ahmed Soomro. After losing his father at a young age, Umais was raised by his mother and uncle, who provided him with love and support despite their limited means. However, his childhood was overshadowed by an unrelenting adversary—an unexplained illness that drained his energy and stole his smile.

From an early age, Umais suffered from persistent fever, weakness, and sickness that no home remedy or local clinic could cure. Determined to find answers, he was taken from one hospital to another. Then, one fateful day, they arrived at AKUH. After thorough examination and advanced diagnostic testing, Umais was finally given a name for his suffering: leukaemia.

The diagnosis was devastating for his family. How could they afford life-saving treatment when they were already struggling to make ends meet? But AKUH had an answer—The Patients' Behbud Society.

With the support of PBS, Umais began his year-long battle. He underwent rigorous chemotherapy and received dedicated medical care. With each passing month, he grew stronger, fighting through the hardest days with unwavering determination. After a year of perseverance, he overcame his illness.

PBS ensures that no patient is ever alone in their fight, allowing individuals like Umais to dream again and live a life free from the burden of illness.

Today, Umais dreams of a new beginning; a life once clouded by illness is now filled with hope for the future.

In 2024, The Patients' Behbud Society for AKUH, disbursed PKR 23 Million to support paediatric oncology.



#### Opinion

#### THE PATIENTS' BEHBUD SOCIETY FOR AKUH NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2024

#### 1. GENERAL INFORMATION

- 1.1 The Patients' Behbud Society for AKUH (the Society) [formerly named as "The Patients' Welfare Society"] was established by well-wishers of the Aga Khan Ur.iversity Hospital (the Hospital) under a constitution dated June 22, 1993 (the Constitution) for supporting needy patients seeking treatment at the Hospital, clinics and medical centers under the Hospital's management and supervision through the funds available with the Society. The Society is currently governed and managed under the amended Constitution of 2002. The Society is registered under the Voluntary Social Welfare Agencies (Registration and Control) Ordinance, 1961 (XLVI of 1961) since August 23, 1993. The principal office of the Society is situated at the Aga Khan University Hospital, Stadium Road, P.O. Box 3500, Karachi 74800.
- 1.2 The following funds are being managed by the Society in order to pursue its aforementioned objectives:

#### (a) Zakat - Externally Restricted

The Zakat Fund of the Society has been established to provide financial assistance to needy patients seeking treatment at the Hospital through Zakat available with the Society.

#### (b) Donations - Unrestricted

The Donations collected by the Society are utilised to provide financial assistance to needy patients seeking treatment at the Hospital.

#### (c) General Fund - Unrestricted

The General Fund is utilised for the marketing and financial expenses of the Society. Donations contributed by the donors for marketing and general purposes/operations are recognised in the General Fund upon receipt.

#### 2. SUMMARY OF MATERIAL ACCOUNTING POLICY INFORMATION

The material accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

#### 2.1 Basis of preparation and statement of compliance

These financial statements have been prepared under the historical cost convention except as otherwise disclosed in the accounting policies below.

These financial statements have been prepared in accordance with the requirements of the Revised Accounting and Financial Reporting Standards for Small-Sized Entities (Revised AFRS for SSEs) and the Accounting Standard for Not for Profit Organisations (Accounting Standard for NPOs) issued by the Institute of Chartered Accountants of Pakistan (ICAP).

#### 2.2 Cash and cash equivalents

Cash and cash equivalents comprise of deposits with banks and short-term investments with banks having an original contractual maturity of less than three months.

#### 2.3 Revenue recognition

- Zakat / donations are recognised on a receipt basis.
- Profit on bank balances and short-term investment is recognised on a time proportion basis on the
  principal amount outstanding using the applicable profit/mark-up rate.
- Donations in kind are recognised at fair value.

#### 2.4 Disbursement

Disbursements are recognised as commitments when these are approved by the Executive Committee. Subsequent to approval, these amounts are paid to the Hospital on behalf of Mustahiqeen patients.

#### 2.5 Taxation

The Society does not account for taxation, as non-profit organisations are allowed a tax credit equal to one hundred percent (100%) of the tax payable including minimum tax and final tax payable, under section 100C of the Income Tax Ordinance, 2001.

#### 2.6 Financial assets and liabilities

Financial assets and financial liabilities are initially measured at cost, which is the fair value of the consideration given and received, respectively. These financial assets and liabilities are subsequently measured at fair value, amortised cost or cost as the case may be. Financial assets and financial liabilities are recognised when the Society becomes a party to the contractual provision of the instrument. Financial assets are derecognised when the rights to the cash flows from the financial assets expire or where the Society transfers the financial assets and the transfer qualifies for derecognition. Financial liabilities are derecognised when the obligation specified in the contract is discharged or cancelled or expired.

#### 2.7 Off-setting of financial assets and financial liabilities

Financial assets and liabilities are offset and the net amount is reported in the statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle either on a net basis, or realise the asset and settle the liability simultaneously. The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency, or bankruptcy of the Society or the counterparty.

#### 3. SIGNIFICANT ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expenses. Actual results may differ from these estimates. Estimates and judgements are continually evaluated and are based on historical experience and other factors. including expectation of future events that are believed to be reasonable under the circumstances Presently no significant estimates/judgements have been made for the preparation of these financia statements.
