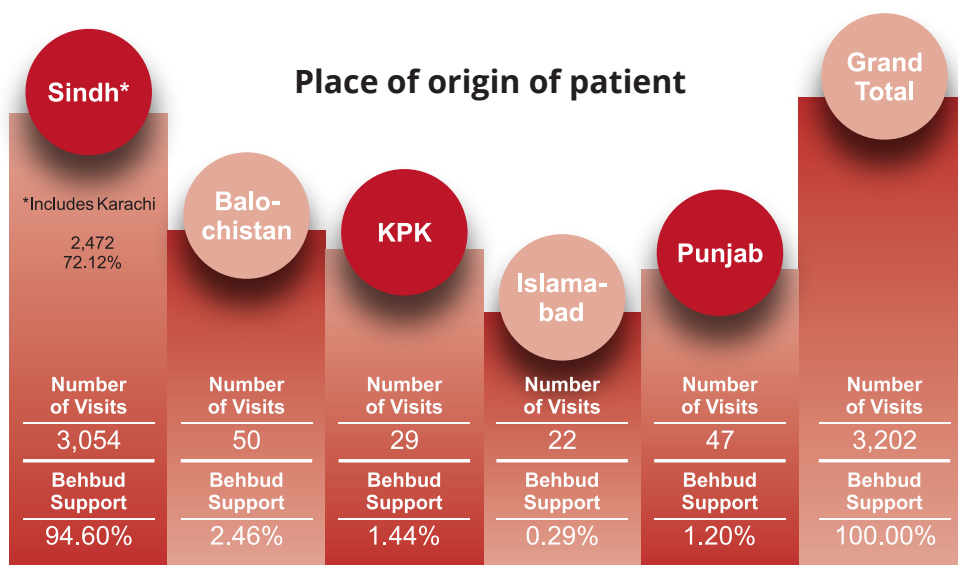
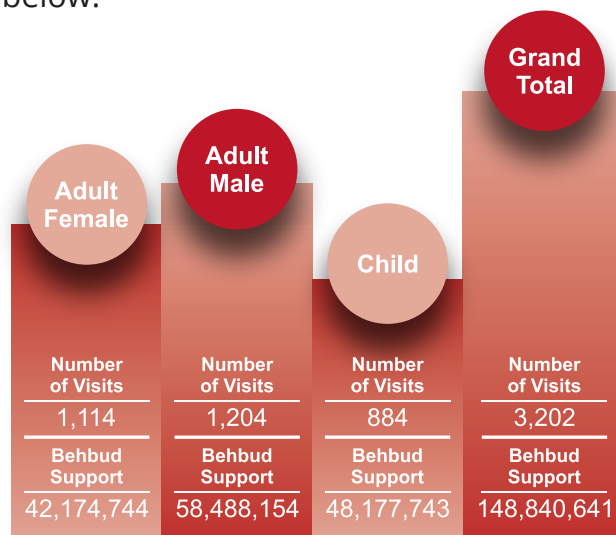

The Patients' Behbud Society for Aga Khan University Hospital (PBS) is registered as an independent, charitable Society engaged in collecting and disbursing zakat, in order to help mustehiq patients receive high quality medical treatment at the Aga Khan University Hospital (AKUH), its clinics and medical centers.

In 2016 alone, thanks to the generosity of our donors, 3,202 patient visits were supported with over Rs 148 million of zakat. 2016 witnessed one of the highest collections and disbursal of zakat since the inception of PBS.

Highlights of 2016

A momentous milestone was crossed during the year: PBS received Shariah certification, based on an extensive review of its processes and documents by highly respected Shariah scholars, Mufti Ibrahim Essa and Mufti Ahmad Afnan, which commenced in September 2016. The independent endorsement of the transparency and authenticity of PBS's zakat collection and disbursal system, is a great achievement and very encouraging for the PBS management and for donors.

During the year, PBS made a number of efforts to reach out to you - our donor - as well as to our patients. We conveyed the importance of the donations we have received through regular dinners and presentations. A dinner was held at the Stadium Road Campus in March 2016 to celebrate 15 years of PBS's work. This event was graced by Pakistani performers, Anwar Maqsood and Bushra Ansari, who entertained guests and were vocal in their support of our cause. Similar donor appreciation dinners were held in Karachi and Lahore in November and December 2017.

Mr Monem, Chairman of PBS and Dr Babar Hasan, Service Line Chief, Children's Hospital, made a presentation about the impact of the Patient Welfare Programme at AKUH, to a packed audience at the Overseas Investors Chamber of Commerce and Industry.

Our cancer specialists also made multiple presentations at corporations and colleges, to create awareness among professionals and students about the symptoms, risks and treatment of breast cancer, during the Hospital's breast cancer awareness campaign in October 2016.

We captured the stories of our patients, and the impact of zakat donations, through regular videos and narratives which were uploaded on PBS's Facebook page and website. We were touched by the encouraging responses we received on social media regarding the Hospital's welfare programme, particularly during the month of Ramadan.

We hope to continue our work, with your commitment and support, during 2017.



Sufiyan's Story

My name is Sufiyan. I live in Bhimpura with my parents and two sisters. My elder brother passed away when I was younger. My father works in a shop that sells tyres and tubes. My illness began with a cough and my condition steadily deteriorated. Despite the number of tests that were conducted, no doctor was able to fully understand my medical condition. My family and I were sitting outside a hospital in our locality, crying in helplessness and fear, when some well-wishers helped us and brought us to Aga Khan University Hospital.



At AKUH I was diagnosed with blood cancer. An operation was performed on me and I was kept in intensive care and observation until my condition stabilized. I will be undergoing chemotherapy for two and a half years, but I feel much better. My family was unable to afford the treatment for my illness. AKUH and The Patients' Behbud Society is helping us. However, we are not treated any differently from other patients. This support is a great source of hope and courage. Dr Sadaf, Dr Zahra, Dr Naureen and the staff do so much for me!

Nehal's Story

My name is Gul Mohammed Nehal. I am from Tharparkar. I work as a cook for a family that owns a farm in Diplo.

One day I was visiting the washroom when I suddenly lost control of movement in my limbs. With great difficulty, I was able to alert a nearby shopkeeper and ask for help. He took me to a local clinic but the doctor was unable to determine the cause of this loss of sensation and movement.

For my employers, I have become like a member of the family. My employer was very distressed at the sudden deterioration in my condition and drove me to Aga Khan University Hospital for treatment. At AKUH, detailed tests proved that I suffered from a rare and potentially fatal disorder of the nervous system called "Guillain Barre Syndrome". I had to undergo intensive treatment for five days. After five days, my condition stabilised. However, it took several months of physiotherapy and rehabilitation for me to be able to walk again and return to Tharparkar. During this time, the nurses and doctors at AKUH were very caring and cooperative. Moreover, AKUH and The Patients' Behbud Society paid for over 70 per cent of the cost of my treatment, while my employer paid for the remaining amount.

I will always remember this frightening episode in my life, but also the support of the Hospital and the family I work for. Without their kindness, I would not be alive today.

2. RESPONSIBILITIES OF THE AUDITORS AND THE MANAGEMENT IN RELATION TO THE FINANCIAL STATEMENTS

The management’s responsibilities include to provide the auditor with (i) all information, such as records and documentation and other matters that are relevant to the preparation and presentation of the financial statements; (ii) any additional information that the auditor may request from management, and where appropriate, those charged with governance; and (iii) unrestricted access to those within the entity from whom the auditor determines it is necessary to obtain audit evidence.

The audit of the financial statements does not relieve the management or the Committee of their responsibilities. Accordingly, our examination of the books of account and records should not be relied upon to disclose all the errors or irregularities in relation to the financial statements.

We would like to advise you that unless we have signed our audit report on the enclosed financial statements, the same shall remain and deemed to be unaudited.

3. COMPLETENESS OF ZAKAT

In any organisation which receives donations (zakat) from its well wishers, an inherent risk exists, whereby the completeness of the donations received in cash cannot always be ensured. In these circumstances, consistent with prior years, we have relied on the management’s assertions as to the completeness of zakat received in cash.

INDEPENDENT AUDITORS' REPORT TO THE MEMBERS

We have audited the accompanying financial statements of the Patients' Behbud Society for AKUH (the Society) which comprise of the financial position as at December 31, 2016, the related statement of income and expenditure, the statement of changes in fund balance and the statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the approved accounting standards as applicable in Pakistan, and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on the financial statements based on our audit. We conducted our audit in accordance with the International Standards on Auditing as applicable in Pakistan. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements present fairly, in all material respects, the financial position of the Patients' Behbud Society for AKUH as at December 31, 2016 and of its financial performance and cash flows for the year then ended in accordance with the approved accounting standards as applicable in Pakistan.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED DECEMBER 31, 2016**

1. GENERAL INFORMATION

1.1 The Patients' Behbud Society for AKUH (the Society) was established by well wishers of the Aga Khan University Hospital (the Hospital) under a constitution dated June 22, 1993 (the Constitution) for supporting needy patients seeking treatment at the Hospital through Zakat funds available with the Society. The Society is registered under the Voluntary Social Welfare Agencies (Registration and Control) Ordinance, 1961 (XLVI of 1961) since August 23, 1993. The principal office of the Society is situated at the Aga Khan University Hospital, Stadium Road, P.O. Box 3500, Karachi 74800.

The following funds are being managed by the Society in order to pursue its aforementioned objectives:

(a) Zakat Fund

The Zakat Fund of the Society has been established for providing financial assistance to the needy patients seeking treatment at the Hospital through Zakat Fund available with the Society. Major contributions include zakat collected, transfer by the Society through the surplus as well as donations received from various sources.

(b) General Fund

General Funds are utilised for meeting general and administrative expenses of the Society. Donations contributed by the donors for general purposes / operations are recognised under the General Fund upon receipt. Major contributions include transfer by the Society through the surplus as well as donations received from various sources.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years, unless otherwise stated.

2.1 Basis of preparation and statement of compliance

These financial statements have been prepared under the historical cost convention except as otherwise disclosed in the accounting policies below.

This is the first set of financial statements prepared by the Society in accordance with the approved accounting and financial reporting standards as applicable in Pakistan as stated below.

Approved accounting and financial reporting standards comprise of Accounting and Financial Reporting Standards for Small Sized Entities (AFRS for SSE) and Accounting Standards for Not-for-Profit Organisations issued by the Institute of Chartered Accountants of Pakistan.



Previously, financial statements were prepared in accordance with the constitution and the directions of Executive Committee of the Society. The change has been made to comply with the requirements of revised TR-5 "IASB Standards - Council's Statement of Applicability" dated February 3, 2016 issued by the Institute of Chartered Accountants of Pakistan. However, there is no change in measurement and recognition impacting these financial statements. Any changes in disclosure requirements have been incorporated in these financial statements.

2.2 Cash and bank balances

Cash and bank balances are carried in the balance sheet at cost. Cash and bank balances comprise of cash in hand and deposits held with banks.

2.3 Revenue recognition

- Zakat and Donation are recognised on receipt basis.
- Profit on bank balances is recognised on a time proportion basis on the principal amount outstanding and at the applicable rate.
- Donations in kind are recognised at fair value.

2.4 Disbursement

Disbursements are recognised as commitments when these are approved by the Committee. Subsequent to approval, these amounts are paid to the Hospital on behalf of Mustahiqeen patients.

2.5 Taxation

The Society does not account for taxation, as non-profit organisations are allowed a tax credit equal to one hundred percent (100%) of the tax payable including minimum tax and final tax payable, under section 100C of the Income Tax Ordinance, 2001.

3. SIGNIFICANT ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of financial statements require management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expenses. Actual results may differ from these estimates. Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectation of future events that are believed to be reasonable under the circumstances. Presently no significant estimates / judgements have been made for the preparation of these financial statements.

4. TRANSITION TO APPROVED ACCOUNTING AND FINANCIAL REPORTING STANDARDS

Transition date is effective from January 1, 2016. The Society has prepared its financial statements in accordance with the approved accounting and financial reporting standards specified in note 2 and there is no change in measurement and recognition impacting prior year financial statements.
